What is a Freight Forwarder?

Technical Description:

A freight forwarder (often just forwarded) is a third party logistics provider. As a third party (or non asset based) provider a forwarder dispatched shipments via asset based carriers and books or otherwise arranges space for those shipments. Carrier types include waterborne vessels, airplanes, trucks or railroad.

Freight forwarders typically arrange cargo movement to an international destination. Also referred to as international freight forwarders, they have the expertise that allows them to prepare and process the documentation and perform related activities pertaining to international shipments. Some of the typical information reviewed by a freight forwarder is the commercial invoice, shipper's export declaration, bill of lading and other documents required by the carrier or country of export, import, or transshipment. Much of this information is now processed in a paperless environment.



ECCN

Export Control Classification Number

- Confirm licensing requirements via Export Control Classification Number (ECCN)
- 3 ways to check:
 - Via exporter/manufacturer
 - Self-classify via Commerce Control List (CCL)
 - Submit formal classification via SNAP-R
- Identifies export controls placed on item
- Where can I find the list?

 - Supplement 1 Part 774/EAR



Schedule B Number

- Used by the US Census Bureau to regulate commodities exported from the U.S.
- Made up of 10 digit code
- Codes determine duty rate (overseas)
- Similar to import HTS codes
- Needed for SLI/SED/EEI filing



Know Who You Are Shipping To/ Selling To

List	Export controls in place	Governed By
Denied Person's List	A list of individuals and entities that have been denied export privileges	Department of Commerce (BIS)
Entity List	A list of parties that may have licensing requirements attached to them per the EAR.	Department of Commerce (BIS)
<u>Unverified List</u>	A list of parties where the BIS are unable to verify the end-user in prior transactions.	Department of Commerce (BIS)
Debarred List	A list complied by the State Department that have been banned from performing in the export of defense articles, the supply of technical data and defense services as per the ITAR.	State Department (ITAR)
Specially Designated National List	Exports to parties on this list may require a license depending on special designations assigned. OFAC may also prohibit a sale to anyone on this list.	Treasury Department (OFAC)



Payment – Banking Issues

- Payment in advance
 - - Most common in export transactions
- Letters of Credit
 - Most secure financial instrument
 - Rules governed by UCP600
- Cash against documents
 - Shipping documents released upon payment
- Documentary collection
- Open account



AES Submission -Automated Export System

- Utilized to electronically file the EEI
- Required to comply with Foreign Trade
 Regulations/government agencies
- Filers of the EEI are:
 - USPPI's
 - U.S. authorized agents



Record Keeping

- 5 Year retention period
- Create a systematic method for filing/retrieving files
- Electronic data storage is adequate
- As a guideline, always keep:
 - Records related to general exports
 - Records of correspondences with foreign nationals
 - Records of correspondences with the US Government
- Need more info?
 - Part 762 of the EAR



Tracking and Tracing

- Pre-shipment details
- Confirmed on Board
- Arrived at Port/Airport
 - Overseas status
